Session Highlights

Congregational Petition: The petition is on the Presbytery Assembly meeting agenda scheduled February 28th. Procedurally, the Presbytery Stated Clerk has advised that we need to submit a written motion prior to the meeting. Session shall prepare the motion and background material for submittal and distribution on February 20. ODCC's Presbytery Commissioner, Bruce Klimek, will make the motion at the meeting. The Assembly vote shall bring closure to efforts to overturn the Committee on Ministry's decision to terminate Rev. Morrison's interim pastoral relationship with the Church.

Interim Pastor Search: As directed by Session, the Clerk reported that the General Presbyter had been contacted after the last session meeting to express Session's disappointment that only one candidate has been submitted by Presbytery to fill the vacant interim position and find out when more candidates can be expected. He reported that no response had been received yet.

Permanent Pastor Search:

- At the urging of Session, the Presbytery Transitional Care Consultant, Jim Yackel, shall advocate that we be permitted to by-pass the interim pastor process if Rev. Morrison is not reinstated, and proceed directly to search for a permanent pastor.
- To commence, Session has scheduled three Congregational Reflection sessions after the second service on March 4th, March 11th and March 25th.

The TCC's expectation is that with the completion of these sessions combined with the Reconciliation Sessions the Presbytery conducted late last year and other prior work, we will satisfy the Congregational Reflection requirements of the process and can move to create a Pastor Nominating Committee.

Called Congregational Meeting: Session has scheduled a specially called Congregational meeting after the second service on March 18th to provide an official report to the Congregation on the Assembly meeting and to discuss pastoral leadership issues – both interim and permanent.


Come join the Prime Timers Tuesday, March 20 at 12:00 noon in the Church fellowship room for their monthly program and luncheon.
